Minutes of 9th Meeting of Syndicate 13th December, 2023.



Hon'ble members actively participated in deliberation. Dr. S.A.K. Azad pointed out to fix the number of seats in accordance with B.C.I. norms and not to adhere the seats allotted by H.P.C. by H.E.D. Odisha. However, in case of old colleges affiliated with Madhusudan Law University to ensure quality in legal education have to resorted to regular classes in case of LL.M. and 5 Year Integrated B.A. LL.B.(H) course especially. In case of irregular classes strict action should be taken against such colleges. Other members also agreed to this.</p>	<p>In case of new colleges approved by H.P.C. / H.E.D. allowed affiliation to run LL.M. with intake of 30 seats, 5 Year Integrated B.A. LL.B.(H) course 60 seats and 3 Year LL.B. course 120 seats. Colleges are also advised to seek requisite recognition from the B.C.I. and in case of colleges running LL.M. have to appoint two teachers with Ph.D. degree and at least one Associate Professor immediately. Moreover, all the affiliated colleges have to follow MLU / B.C.I. regulations/rules in letter and spirit.</p>
